

## **CONSULAR VISA FEES**

January 2021

**THE PAYMENT OF CONSULAR FEES MUST BE MADE EXCLUSIVELY THROUGH MONEY ORDER, CASH PAYMENT IS NOT ACCEPTED**

(The consular fees are updated by Law. Please check the current rate at the time of processing)

1.- In general, the processing fee for a visa application is:

- o Schengen visas (short term) \$ 97
- o National visas (long term) \$ 73

2.- **Short-stay visas** (tourism, business, etc.):

- o Under 6 years old - \$ 0
- o Children between 6 and 12 years old - \$ 49

3.- Visas Agreements of the European Union: nationals of North Macedonia, Bosnia and Herzegovina, Albania, Moldova, Serbia, Russia, Ukraine, Armenia, Azerbaijan, Cape Verde and Georgia: - \$ 43

4.- Supplementary costs **for US citizens**:

- o In general (non-profit residence, retirees ...) - \$ 140
- o Study visas - \$ 160
- o Work visas for others - \$ 190
- o Self-employment visas - \$ 270

- o Initial temporary residence authorization - \$ 13
- o Initial authorization of residence Entrepreneurs Act - \$ 88
- o Long-term residence authorization - \$ 26
- o Initial self-employment authorization - \$ 245
- o Authorization work transnational benefits lasting more than 6 months:
  - o Remuneration less than 2 times S.M.I. (Minimum Interprofessional Salary) - \$ 245
  - o Remuneration greater than 2 times S.M.I. (Minimum Interprofessional Salary) - \$ 491
