



PREVIOUS REQUIREMENTS

You must appear **in person**. Applicants must have permanent residency status in the US.

The request for a visa must be made at the Consulate of Spain which has jurisdiction over the state where the applicant resides. This Consulate General has jurisdiction over the following states: **New York, New Jersey, Connecticut, Pennsylvania and Delaware.**

The visa will be affixed to your passport, before the departure. It is not possible to request the visa in Spain or do the process through the mail.

WHAT IS A RESIDENCE VISA FOR INVESTORS OR SELF-EMPLOYMENT?

This visa allows a foreigner, 16 years and older, to work in Spain.

SPECIFIC REQUIREMENTS

Applicants **must submit originals and 1 copy of the below mentioned documents**. If your documents are accepted to process the visa they will not be returned.

1. Two [national visa application forms](#) duly filled out and signed.
2. **Passport** valid for a minimum of four months with at least two blank pages to affix the visa.
3. Two passport size **photographs** in color, 2 x 2 inches (51 x 51 mm) in size, printed on matte or glossy photo quality paper, taken within the last 6 months to reflect your current appearance and in front of a plain white or off-white background.
4. **Non-US citizens:** Alien Residence Card (Green-Card) or residence visa valid in USA (except B1, B2).
5. **Copy** of the **Police Record Certificate** for persons 18 years old and up from the country of origin or place of your residence for the last five years, bearing the "Apostille of the Hague Convention" (see additional information below). If the certificate is issued outside the US it must be duly legalized by the corresponding Consulate of Spain plus one copy. The **original** certificate must be kept and brought to Spain in case of being required by the Spanish Police.
6. **Medical certificate:** doctor's statement on a doctor or medical center letterhead, indicating that the applicant has been examined and found in good physical and mental health to travel to study abroad and is free of contagious diseases or any other illnesses which could lead to public health repercussions according to the International Sanitary Regulations-2005 of the [World Health Organization](#).
7. **If needed**, proper **Academic Title or Degree required in your line of work**. The Title or Degree must be duly legalized for Spain and **translated into Spanish**.
8. **Documentation** that shows that you are **financially sound** or letter/s from the bank/s regarding that matter and translated into Spanish.



9. **Work or Investment Project** that shows the kind and/or type of business to conduct as well as the projected financial gains and, if applicable, any work positions to be created by such project and translated into Spanish.
10. If you apply with your **family**: documents that prove your family ties, translated into Spanish:
 - a. From your spouse: original marriage certificate and background check, with [apostille](#).
 - b. From your children: original birth certificate/s, with [apostille](#).The family members will have to fill out the [EX-01](#) and [Modelo 790 Código 052](#) forms and submit the rest of general requirements that apply for their cases listed for this type of visa.
11. List of the **authorizations and/or permits** required to open or conduct your future business along with the status of such permits and/or licenses already obtained if any from the proper authorities.
12. **Money Order** to pay the **non-refundable**. Consult our [consular fees](#).
13. **Mandatory**: authorization residence visa for investors or self-employment issued by *Delegación o Subdelegación de Gobierno* appropriate. More information here.

ADDITIONAL INFORMATION

Once the visa is collected, you must enter Spain within the period the visa is valid for and your entry date must be stamped on your passport or travel document. After that -and **within one month of your arrival in Spain- you must request in person your residency card** from the Police Department in Spain (*Oficina de Extranjería*). Once you enter Spain, you can start working and you must register with the Social Security System as established by law.

Special notes for police certificates

US records issued by the **F.B.I. or State Police background checks are valid. Local Police background checks will not be accepted.**

Also remember that an [apostille certification is required for Spain](#). An apostille is a certification that a document that has been “legalized” or “authenticated” by the issuing agency through a process in which various seals are placed on the document.

Does the FBI provide apostilles?

Yes. The CJIS Division will authenticate US Department of Justice Order 556-73 fingerprint search results for international requests by placing the FBI seal and the signature of a division official on the results if requested at the time of submission.

Documents prepared in this way may then be sent to the US Department of State by the requester to obtain an apostille if necessary. This procedure became effective on January 25, 2010 and will apply only to documents finalized after that date. Requests to authenticate previously processed results will not be accepted.

This procedure replaces the letter formerly provided by the CJIS Division that indicated the service was not provided. The apostille service is not provided to individuals requesting search results for Canadian immigration, as it is not required for this purpose.
