

## TRAVELERS AUTHORIZED TO ENTER SPANISH TERRITORY

# 1. Travelers from the USA to Spain must meet ONE of the following health requirements (provided they are over 12 years old):

## 1.1 Vaccination, recovery or diagnostic certificate

Please note that you may present an EU-COVID Certificate or a certificate of vaccination, recovery or diagnosis issued in any country outside the European Union (such as United States) as long as these certificates meet certain requirements.

**1.1.1 Vaccination certificate (at least 14 days from the last dose of vaccination).** Accepted vaccines: Pfizer-Biontech, Moderna, Astra-Zeneca, Jansen/Johnson&Johnson, Sinovac and Sinopharm.

Notice: Keep in mind that you will need 14 days from the last dose at least and no more than 270 days since the date of administration of your last dose. From that moment on, your vaccination certificate must show the administration of your booster dose.

Is the booster dose applicable for children? Please keep in mind that the obligation for the booster dose and the expiration date of 270 days do not apply for children over 12 and under 18 years old. Therefore, if you are over 12 and under 18 years old, you are considered as vaccinated even if 270 days have passed since the last dose without having received the booster dose.

The vaccination certificate must include at least the following information:

- Name and surname of the holder.
- Vaccination date, indicating the date of the last dose administered.
- Type of vaccine administered.
- Number of doses administered / complete regimen.
- Issuing country.

- Identification of the issuing body of the vaccination certificate.
- **1.1.2.** Diagnostic certificate. You must show a negative COVID-19 test result. NAAT (PCR, LAMP, TMA or equivalent) test types are accepted in Spain. You must show a negative result of a NAAT test taken within 72 hours OR an antigen test taken within 24 hours prior to your departure.

## 1.1.3. Recovery certificate.

Certificates of recovery issued by the competent authority or by a medical service at least 11 days after the first positive NAAT or rapid antigen detection test will be accepted as valid. The certificate shall be valid for 180 days after the date of the first positive diagnostic test result.

Certificates must be written in Spanish, English, French or German. If it is not possible to obtain it in these languages, the document must be accompanied by a translation into Spanish made by an official translator.

# 2. The SptH entry form:

Please note that if you have a COVID-EU Certificate issued by any EU country or equivalent you may substitute the SpTH (Spain Travel Heath) for the COVID-EU Certificate. At this moment the COVID certificate issued by the USA is not considered as equivalent. Therefore you will need to fill in the SpTH form, download your QR code and present it to the authorities on your mobile device or printed on paper.

If your COVID Certificate has been issued by a country other than USA please check if you need to fill in the SpTH form and download a QR code before your trip to Spain.

Children under the age of 12 and passengers in international transit do not have to show a certificate or SpTH QR.

## 3. Health check upon arrival in Spain:

Travelers arriving in Spain by air or sea from countries that do not belong to the European Union or are not considered Schengen associated countries may be subjected to a health control at the first point of entry that will include, at least, temperature monitoring, documentary control and a visual check on their physical condition.
