



## **Visa for investors**

*Non-resident foreign nationals intending to enter Spain for the purpose of making a significant capital investment may apply for a stay visa or, where applicable, a residence visa for investors with one year validity. For more information on the level of investment required please check the article 63 and following of the [Act 14/2013, of 27 September, of support to entrepreneurs and their internationalization](#).*

*The applicant or an authorized representative should come to the Embassy of Spain without appointment (check [our address and opening hours](#)) to submit the application. When submitting a long-stay visa application a consular fee must be paid in Indian rupees via a draft issued to the Embassy of Spain. Since consular fees are set out in euros, they are subject to change. Please check our updated [list of consular fees](#).*

### **Documents**

- One application form for national visa properly completed (full postal address, email address and telephone should not be omitted), dated and signed in blue ink. The visa application form is free of charge and can be downloaded [here](#). One photograph not older than 6 months of the applicant, 35-45 mm and with a white background, should be affixed on the application form.
- Passport of the applicant with at least two blank pages, valid for the entire duration of the envisaged stay in Spain.
- One copy of the pages of the passport with biographic data (in the case of an Indian passport, at the beginning and the end).
- Original criminal record certificate(s)<sup>1</sup> of the countries where the applicant has resided for more than 6 months in the previous 5 years. If the applicant has resided in India, the criminal record certificate or Police Clearance Certificate must be issued by the regional passport office. Criminal record certificates are only valid for 3 months from the date of issuance.
- A copy of the former document(s).
- Evidence of a public or private health insurance policy with an insurance company authorized to operate in Spain.
- Evidence of sufficient economic means to ensure accommodation and livelihood of the main applicant and family member(s) during the entire duration the applicant stay in Spain. Estimated monthly livelihood cost in 2019 for the main applicant is 2,151.36 euros and 537.84 euros for each accompanying family member. ITR for last 2 years and original bank statements for last 6 months can be used as proof.

### **Specific documents depending on the kind of investment<sup>2</sup>**

- Public debt: certificate from the financial institution or the Central Bank of Spain.
- Unlisted shares and equity: statement of investment filed with the Investments Register of the Directorate-General for International Trade and Investments (DGCOMINVER)
- Listed shares: document from a financial broker registered with the National Securities Market Commission (CNMV) or the Central Bank of Spain
- Investment funds: certificate from the fund manager.
- Bank deposits: certificate from the financial institution.
- Property: certificate of property registration and real estate purchase deeds. If the purchase is not formalized: engagement contract formalized in public deed.
- Business project: a favorable report from the DGCOMINVER.

<sup>1</sup> Public documents (criminal record, marriage, birth certificates) must be submitted either with the Hague apostille or duly legalized and accompanied by an [official translation](#). ### **Documents for family members**

*The following family members of the main applicant are eligible to apply under this category:*

- 1) Spouse or person with a similar personal relationship*
- 2) Children below 18 years or above 18 if they are financially dependent on the main applicant and have not formed a family unit for themselves*
- 4) Parents dependent on the main applicant, accompanying or reuniting with the main applicant.*

Each application of a family member should include all the basic documents listed above. The evidence of sufficient economic means can be the same for the family unit. Children below 18 are exempted from criminal record certificates. Each application must also include evidence of the family relationship (i.e. birth or marriage certificate) issued by the relevant Civil Registry<sup>1</sup>.
