



## HUNTING AUTHORIZATION

You can apply for a hunting authorization 60 days prior to your flight to Spain. You will have to do it even if you are not going to carry any guns.

Applications are accepted only by postal mail to:

Consulate General of Spain in Chicago  
(Hunting Authorization)  
180 North Michigan Ave., Suite 1500  
60601 Chicago, Illinois.

The hunting authorization might take two (2) weeks, once all requirements are correctly received. The Consulate does not track mail or answer emails/ phone calls regarding hunting permit status.

## DOCUMENTS REQUIRED

**EACH DOCUMENT MUST BE SENT WITH ITS PHOTOCOPY  
BE ADVISED THAT ADDITIONAL REQUIREMENTS MIGHT BE REQUESTED.**

1. Application form fully filled out and signed (see below).
2. Translation form fully filled out and signed (see below).
3. Notarized copy of applicant's passport.
4. Notarized copy of applicant's US hunting permit/license (valid for your entire stay in Spain).
5. Notarized copy of applicant's US driving license with actual address.
6. Letter of invitation from the institution/club, with a copy of the ID of the person who signs the invitation letter.  
It must state:
  - Dates, location, province and autonomous region where the hunting is going to take place.
  - Whether the guns are owned by the institution/club or by the applicant.
7. In this latter case, as applicant's proof of ownership of the gun you have to provide from Department of Homeland Security a "Certificate of Registration for personal effects taken abroad".
8. \$50 Money Order payable to Consulate of Spain in Chicago.
9. Only USPS pre-paid self-addressed envelope with a tracking number (no Fedex, no UPS). We won't accept envelopes without tracking number.
10. Postal delivery authorization fully filled and signed (see below).
