

WORK AND RESIDENCE PERMIT FOR SELF-EMPLOYED


DOCUMENTS REQUIRED

- 2 <u>National visa application</u> forms, duly filled out, signed by the person in whose name the visa will be issued and 2 recent passport size photographs in colour and with white background attached to the form.
- 2. Power of attorney for representatives in case the application is not presented by the applicant. A photocopy of the same must be submitted.
- Payment of <u>Visa fees</u> must be done only through demand draft in favour of CONSULATE GENERAL OF SPAIN. Two photocopies of demand draft must be submitted.
- 4. Application form for authorisation of Residence and Authorisation of Work and Residence permit (Form EX 07).
- Form Modelo 790, code 052 Proof of payment of the fees for the residence application procedures. A photocopy of the same must be submitted. Consult corresponding fee.
- 6. Form Modelo 990 Proof of payment of the fees for the initial authorization of work permit for self-employed. A photocopy of the same must be submitted. Consult corresponding fee.
- 7. Passport with a minimum validity of 4 months and photocopy of all pages of the same.
- 8. <u>Police Clearance Certificate</u> issued by the competent authorities of the country where the applicant has resided in the last 5 years prior to the submission of the visa application, legalised + authenticated or apostilled.
- 9. <u>Medical certificate</u> issued by any registered medical practitioner updated.
- 10. A public or private medical insurance policy issued by an insurance company authorised to operate in Spain. The medical insurance policy must cover the entire period of stay in Spain, the medical expenses and the repatriation associated with an accident or a sudden illness. A photocopy of the same must be submitted.
- 11. Proof of accommodation in Spain that is equal to or superior to the average level of accommodation expenses of Spanish nationals in that region. A photocopy of the same must be submitted.





- 12. Documents that justify sufficient economic means to bear the living expenses, including if applicable, expenses of the family, during the period of stay in Spain. In case the financial documents submitted are deriving funds from the business, the valuation of the same will be done once the requirements for maintenance of the business are concluded. All the documents must be translated to Spanish, if not in English. A photocopy of the same must be submitted.
- 13. Justify the capacity and, if applicable, the legally required qualification for professional purposes. <u>The documents must be translated to Spanish</u>. A photocopy of the same must be submitted.
- 14. Project report for the establishment or the activity, with an indication of the estimated investment, expected profitability and, if applicable, estimate the creation of job posts, as well as the documentation that justifies that they possess the necessary investment for the implementation of the project or with the guarantee of sufficient support from financial institutions or other institutes. The documents must be translated to Spanish. A photocopy of the same must be submitted.
- 15. List of authorizations or licenses that will be required for the establishment, inauguration or functioning of the projected activity or for professional purposes, that indicates the current status of the procedures, including, if applicable the proof of applications submitted to the corresponding organizations. A photocopy of the same must be submitted.
- 16. In case of family members' dependent on them, they must justify with documents the family bond relation with the principal applicant, and the documents must be legalized (apostilled) and translated to Spanish. A photocopy of the same must be submitted.
- 17. In case of minors' dependent on them, they must present documents of school admission in Spain of the minors who are the dependents of the principal applicant. A photocopy of the same must be submitted.





OTHER REQUIREMENTS AND OBSERVATIONS

TRANSLATION: <u>Sworn translation</u> to Spanish from source language if the original documents are in a regional or foreign language, including English (except passports and economic proof documents).

PHOTOCOPIES: Kindly note that for each original document presented a photocopy of the same must be submitted. The photocopies must be made after legalising the translations and/or the documents.

INTERVIEWS: At any time during the visa application procedure, this Consulate General may require the personal appearance of the applicant, and if considered necessary, conduct a personal interview.
