

EUROPEAN UNION/ EUROPEAN ECONOMIC AREA/SWITZERLAND FAMILY MEMBER VISA WHO ARE NATIONALS OF A THIRD COUNTRY

Relatives of EU/EEA/Swiss citizens can submit their Schengen visa application at both the Embassy of Spain in Ireland or BLS, our outsource partner. To get an appointment at the Embassy, please write an email to emb.dublin.vis@maec.es. To get an appointment go to BLS website.

If the applicant travels with or to join the EU/EEA/S citizen, the visa will be issued free of the standard consular fee (€80). Processing fees will apply when the visa application is submitted at BLS.

Family members of an EU/EEA/Swiss citizen have priority to apply for and get their visas.

The nationalities requiring a visa are listed in Annex I of Regulation (EU) 2018/1806.

Family members in possession of a valid IRP/GNIB card with a 4EuFam stamp are exempted of visa to enter into Spain if they accompany or are to join the EU/EEA/S citizen. Furthermore, upon presentation of their residence card, their passports will not be stamped either on entry or on exit of Spain. Family members with any other IRP/GNIB stamp do require a visa.

Core family members are:

- The spouse, if there has been no annulment or divorce.
- The partner registered in EU/EEA/S country, if such registered partnership has not been legally terminated.
- Direct descendants of the EU/EEA/S citizen or of their spouse or registered partner (if there has been no annulment or divorce or legal termination of the registration), who are under the age of 21 and above that age, if they are dependants or disabled.
- Direct relatives in the ascending line of the EU/EEA/S citizen or of their spouse or registered partner (if there has been no annulment or divorce or legal termination of their registration) that are their dependants.
- Exceptionally, other family members when serious health grounds or disabilities strictly require their personal care by the EU/EEA/S citizen.
- The unregistered partner, provided that stable cohabitation for a minimum period of one year can be duly attested. When they have children in common, it will be sufficient to ascertain stable cohabitation.

Please find here below the list of required documents.

Original and copy of the documents marked with * are required

- o A Schengen visa application form, completed, dated and signed.
- o Passport * of the applicant with at least two consecutive blank pages, valid for at least three months after duration of the trip and issued in the last ten (10) years.
- A recent passport-sized photograph of the applicant (35-45 mm), on a white background, full front, on which the applicant
 must be bareheaded, without dark glasses or any other item that may hinder identification. Veils or head coverings are
 permitted on religious grounds, provided all facial features are clearly shown on the photograph. If the applicant is a
 minor, one of their parents must sign the application.
- o Irish certificate of registration * (IRP/GNIB card) or re-entry (when applicable for minors) valid for at least three months after the duration of the trip.
- Passport * of the EU/EEA/Swiss citizen (or also DNI, if he/she is Spanish). The EU/EEA/Swiss citizen can also accompany
 the applicant and produce his/her original passport or Spanish DNI.
- Evidence that the applicant is traveling with the EU/EEA/Swiss citizen (flight tickets) or joining them in Spain (flight ticket and written declaration signed and dated by the EU/EEA/Swiss citizen, invitation letter (*Carta de invitación*) issued by the Spanish National Police).
- Evidence of the family relationship: birth, marriage or legal partnership certificate, as applicable. If those documents are from third countries and do not have the Hague Apostille nor are legalised, any other official document or communication that proves the relationship may also be added to the application or requested by the Embassy. Only certificates issued by the Spanish Civil Registry will be accepted as evidence of a marriage with a Spanish national.
- In the case of children over 21 years of age, ascendants and other relatives who are dependants of the EU/EEA/S citizen
 proof of that economic dependency.
- o In the case of a family member in the care of the EU/EEA/S citizen on health or disability grounds, Irish medical certificate with indication of the condition and the caring person.
