

In reference to point nº 4 of the rules governing the selection process to fill in the vacancy of a chef's position at the Embassy of Spain published on 29 June 2023, the selection tribunal resolves the following:

FIRST

Approval of the complete certifed list of those candidates accepted and excluded in the selection process, on reaching the deadline for submission of applications.

The list of accepted and excluded candidates (as per enclosed Annex I), with description of reasons for exclusion, if applicable, will be published on the web page of the Embassy of Spain, <u>www.exteriores.gob.es/Embajadas/harare</u>, and on the notice board of the Embassy of Spain at 16 Phillips Avenue, Belgravia, Harare, Zimbabwe.

SECOND

All candidates excluded and omitted have a period of five working days from the next day of publication, to amend those defects causing the reason for their exclusion or omittion.

All candidates that, following the said period, do not amend the reasons for their exclusion or omittion, hence justifying their readmission into the process, will definitely be excluded of the process.

Once this grace period concludes, a new list of accepted and excluded candidates will be published in the same manner as previous lists.

If no allegations have been carried out within the grade period, the published list of accepted and excluded candidates will then become final.

THIRD

As part of the selection process, ONLY ACCEPTED CANDIDATES detailed on Annex II are summoned to carry out a practical exercise that will take place 24th, 25th and 26th July at the Residence of the Ambassador of Spain at 21 Cardinals Road, Chisipite, Harare.

FOUR

Selected candidates are requested to report to the above mentioned address 20 minutes before their allocated times with their identification document, passport or driver's licence as well as one or more writting pens. Candidates do not need to bring any other materials for the practical test. All required materials and cooking ingredients will be provided by the Embassy of Spain at the time of the test.

During access to the examination centre and carrying out of the practical exercise, all selected candidates must follow all security measures and instructions as indicated by the responsable Embassy personnel.

Candidates will be summoned only once to the above mentioned exercise and those who do not respond will be automatically excluded.

FIFTH

Recourse against the present resolution can be presented, alternatively, before the issuing authority, within one month of publication, according to articles 123 and 124 of Law 39/2015, 1st October, of the Common Administrative procedure of the Spanish Public Administration, otherwise recourse can be submitted before the High Court of Justice in Madrid, within two months of publication, according to articles 10.1.i) and 14.1. second of Law nº 29/1998, of 13 July, that governs the this type of procedures.
