## VISAS FOR ARTISTS (MUSICIANS)

This visa is valid for artists going to the Schengen Area (with main destination in any of the following States: **Spain, Austria, France, Greece, Hungary, Latvia, Malta, Portugal, Poland, The Czech Republic, Slovenia, The Slovak Republic** and **Switzerland** for specific performances that do not exceed 5 consecutive days or 20 non consecutive days within a 3-month period.

### REQUIREMENTS:

1. **Schengen visa application form** completed with signature and date of application, including one passport size photograph.
2. **Copy of passport data page**
3. Valid **passport**. If passport has been issued less than one year the previous expired passport is also required. Passport must be valid for at least 3 months after the validity of the visa.
4. **Photocopy of D.N.I or passport of promoter or manager** in Schengen country.
5. **Contract** with the name of the artist.
6. **Schedule of appearances, tours** etc
7. **Copy of authorization or permit** required for staging of artistic events indicating the current state of the application process including where necessary the certification for the request submitted to the corresponding organisation. If at a public event (Music Festival etc.)
8. **Complete travel Itinerary** showing departure from and return to home country, and entry to and exit from all Schengen states being visited (DO NOT purchase airline ticket prior to submission).
9. **Confirmed hotel reservation**. If applicant will be staying at a private home, the original letter of invitation previously processed by National Authorities will be required.

10. **Travel Health Insurance** with minimum coverage of thirty thousand Euros, including repatriation of mortal remains. The insurance company must have an office in a country in the Schengen area and must provide up-front coverage which the insured may require (the insured should not be required to make any advance payment).

- Complete **separate applications are required for each applicant**. The required documentation must be in the name of the specific artist.
- Please include originals of all documents. The Embassy will evaluate the documentation and request additional documents where necessary. **Please note that each applicant must have his/her own copies of each required document (even when travelling as a group).**

**Processing time** is 10 calendar days. Applications may be submitted within 180 days of travel date, no earlier.

**Processing Fees** (non-refundable and are subject to change): J\$ 16,493.00. **Please, take exact change.**

**IMPORTANT!**

**NO firearms or weapons allowed! Persons carrying firearms or weapons will NOT be permitted entry.**
