#### THE ADMINISTRATIVE BOARD OF THE EUROPEAN FISHERIES CONTROL AGENCY

Having regard to Council Regulation (EC) No 768/2005 of 26 April 2005<sup>1</sup> establishing a European Fisheries Control Agency (hereinafter referred to as 'EFCA'), and in particular Article 19(3) thereof,

Having regard to Commission Decision C (2008) 6866 of 12 November 2008 laying down the rules on the secondment to the Commission of national experts and national experts in professional training,

Having regard to AB Decision No 09-I-07 of 19 March 2009 concerning the Revised Rules for Seconded National Experts,

#### Whereas:

- (1) SNEs at EFCA may perform the same duties as temporary agents on stand-by duty. Therefore, provision should be made, so that the related stand-by duty allowance may also be granted to SNEs.
- (2) AB Decision No 09-I-07 should therefore be amended,

HAS DECIDED AS FOLLOWS:

# Sole Article

AB Decision No 09-I-07 is hereby amended as follows:

1. The following article is inserted after article 17:

'Article 17a

Stand-by duty allowance

Without prejudice to the rules on subsistence allowances laid down in article 17, the rules in force at EFCA on allowances for regular stand-by duty, applicable to EFCA staff, shall apply to SNEs<sup>2</sup>.'

2. This Decision shall take effect on the day of its signature.
