We are:

The European External Action Service (EEAS) supports the High Representative in the exercise of his mandate to conduct and implement an effective and coherent EU Common Foreign and Security Policy (CFSP), of representing the EU and of chairing the Foreign Affairs Council. It also supports the High Representative in his capacity as Vice-President of the Commission with regard to his responsibilities within the Commission in the external relations field including the coordination of other aspects of the EU's external action. The EEAS works in close cooperation with the General Secretariat of the Council, the services of the Commission and the Secretariat General of the European Parliament.

We propose:

The position of Seconded National Expert (SNE) covering counter terrorism and related security issues at the **EU Delegation to Algeria** as a "co-financed" secondment, i.e. salary, insurances, accommodation and other costs are to be paid by the EU MS as appropriate and specific allowances to be paid by the EEAS.

Overall purpose: to monitor and report on CT-related security developments, providing analysis, and giving advice on the EU's action, including preventing and countering violent extremism, (de)radicalisation, countering the financing of terrorism, and countering transnational and organised crime linked to terrorist activities. Due attention to human rights and the rule of law which are central the EU's approach to countering terrorism, should be given. The position is based at the EU Delegation in Algiers. The Expert will be required to travel in the region, as appropriate and necessary. S/he Expert will be a member of the EU CT/Security Experts' Network and, as such, will be accountable to EEAS HQ for related tasks and assignments.

We are looking for:

The EEAS is seeking a highly motivated colleague to occupy the post of SNE covering counter terrorism and security issues relating to Algeria.

The Expert will:

- Monitor, analyse and provide advice on the terrorism landscape and related security developments in Algeria and the region, including the impact on EU interests. This will include preventing and countering violent extremism, (de)radicalisation, countering terrorist financing and money laundering, and countering transnational and organised crime linked to terrorist activities, including drug trafficking and trafficking of human beings. The Expert will work in close cooperation with other EU (including Member States) actors present in the country, as well as with other CT/Security Experts in the region. S/he will pay due attention to human rights and the rule of law, therein, as central elements of the EU approach to countering terrorism:
 - Establish and maintain technical-level relations with the national/regional authorities, including and other local counterparts on counter terrorism, countering and preventing violent extremism and other security issues relating to counter-terrorism;
 - Provide regular and timely analysis and reporting to the Security and Defence Policy Directorate (CT Division)
 via the Delegation, and to all other relevant services at EEAS Headquarters, on the above topics and related
 aspects including through monthly reports and flash reports, early warnings, , info flashes, "think pieces", as
 well as in response to specific requests;
 - Promote and raise awareness of the authorities and other regional players on EU policies, strategies, initiatives and actions concerning counter terrorism, countering and preventing violent extremism and other relevant security issues;

- Ensure close coordination with EU Member States, like-minded States and the UN, at the level of counter terrorism advisers, security advisers and police liaison officers, by convening and/or participating in coordination meetings on counter terrorism and related security matters pertaining to Algeria and the region;
- Develop and maintain a network composed of relevant local and regional actors on counter terrorism and related security issues from Algeria, as well as regional organisations including the Africa Centre for the Study and Research of Terrorism (CAERT), Member States, UN agencies, NGOs and local and international civil society, and bilateral and regional partners;
- Contribute to the preparation of and participate in Dialogues on counter terrorism and related security matters relevant to Algeria, as well as any follow-up, contribute to briefings and the preparation of HQ and other visits, and provide general analytical input;
- Cooperate closely with EEAS and Commission services (including FPI, INTPA and HOME) in the identification, formulation and implementation of EU policies, programmes, projects and activities in Algeria and the region concerning counter terrorism and related security issues in collaboration with the Delegation and the Security and Defence Policy Directorate (CT Division);
- Ensure communication and visibility of EU policies and actions, including counter terrorism and related security aspects in the communication strategy of the EU Delegation.

Legal basis:

This vacancy is to be filled in accordance with EEAS Decision of the High Representative of the Union for Foreign Affairs and Security Policy Decision HR DEC (2014)01 of 04/02/2014 establishing the rules applicable to National Experts seconded to the European External Action Service.

Eligibility criteria:

Candidates must:

- a) Be drawn from public administrations in Member States, from international organisations or, only in exceptional cases and with prior authorisation from other sources;
- b) Have at least three years' full-time experience of administrative, scientific, technical, advisory or supervisory functions equivalent to those of function groups AD or AST as defined in the Staff Regulations of Officials of the European Union and the Conditions of Employment of other servants of the Union₁ or, where justified in the interests of the service, professional training of an equivalent level.
- c) Have a thorough knowledge of one Union language and a satisfactory knowledge of a second language for the performance of his/her duties.
- d) Have a security clearance of minimum level EU-SECRET for the functions that he/she will carry out.
- e) Remain in the service of the employer throughout the period of secondment and shall be paid by that employer.
- f) Remain subject to the social security legislation applicable to the public administration, international administration or entity which employs the SNE and which will assume responsibility for expenses incurred abroad. In case of posting to an EU Delegation, the employer certifies that the SNE is covered for medical expenses incurred at the place of secondment, as well as costs of repatriation on health grounds throughout the full period of secondment
- g) Ensure that there is no conflict of interest and that they will, at all times, safeguard the independence and coherence of EU foreign policy as well as the integrity and confidentiality of EU documentation, information and procedures.

Selection criteria:

Candidates should:

A. Professional knowledge

 Have a professional experience of at least 5 years, preferably in the Ministry of Foreign Affairs, Ministry of Interior, Ministry of Justice or Police with experience in counter terrorism, prevention of violent extremism, deradicalisation, peace and security, transnational crime or related issues, ideally from work in the region.

- Have extensive knowledge of the above-mentioned policy areas are required, including conflict sensitive analytical capacities, counter terrorism and security policies in Member States or international organisations and diplomatic representations.
- Good working knowledge of the EU (institutional) environment and instruments in the area of EU external
 and peace/security policy is desirable, as is previous experience in and related to Algeria and the Maghreb
 region.
- Proven reporting and analysis capacity is required.

B. Skills

- Have the capacity to work and communicate under time constraints in an international diplomatic and multilingual environment. Intercultural sensitivity skills are required.
- Be a team worker and have good coordination and communication skills. Ability to build and maintain a network of governmental and non-governmental stakeholders.
- Have solid analytical capability as well as drafting and reporting skills. Rapid grasp of problems and capacity to identify issues and solutions.

C. Mandatory training

Hostile Environment Awareness Training (HEAT) is recommended for this posting.

D. Languages

A thorough knowledge (capacity to write and speak) of French and English is required. Knowledge of Arabic
or other local language(s) would be an asset.

E. Personal Qualities

 Dynamic, motivated and flexible personality. Ability to adapt quickly to new situations and deal with new challenges, including missions in remote areas.

F. Equal opportunities

- The EEAS is committed to an equal opportunities policy for all its employees and applicants for employment. G. Conditions of secondment

SNEs shall remain in the service of their employer throughout the period of secondment and shall continue to be paid by that employer. The EEAS will provide for the allowances in order to contribute to cover the SNE's living expenses in the place of secondment on a flat-rate basis. These allowances shall not be construed as remuneration paid by the EEAS.

Duration of the secondment: 2 years

Co-financed SNEs shall be entitled to a:

- daily allowance (160.03 €/ calendar day) throughout the period of secondment
- monthly allowance calculated according to the distance between the point of origin of the employer and the place of secondment (between 0 to 903.12 €/month)
- Living Condition Allowance: 30%

The EEAS will cover for security and missions costs incurred by the SNE posted in the EU Delegation. Other costs such as removal costs, salary, insurance, schooling etc. shall not be covered by the EEAS.
